

# VIPcom Software License Agreement

IMPORTANT: PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE USING THE SOFTWARE.

VIPCOM GMBH (“VIPCOM”) IS WILLING TO LICENSE THE SOFTWARE TO YOU AS THE INDIVIDUAL, THE COMPANY, OR THE LEGAL ENTITY THAT WILL BE UTILIZING THE SOFTWARE (REFERENCED BELOW AS “YOU” OR “YOUR”) ONLY ON THE CONDITION THAT YOU ACCEPT ALL OF THE TERMS OF THIS LICENSE AGREEMENT. THIS IS A LEGAL AND ENFORCEABLE CONTRACT BETWEEN YOU AND VIPCOM. BY CLICKING THE “ACCEPT” OR “YES” BUTTON YOU AGREE TO THE TERMS AND CONDITIONS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, CLICK THE “I DO NOT ACCEPT” OR “CANCEL” BUTTON OR OTHERWISE INDICATE REFUSAL, MAKE NO FURTHER USE OF THE SOFTWARE, AND CONTACT VIPCOM CUSTOMER SERVICE FOR INFORMATION ON HOW TO OBTAIN A REFUND OF THE MONEY YOU PAID FOR THE SOFTWARE (LESS SHIPPING, HANDLING, AND ANY APPLICABLE TAXES) AT ANY TIME DURING THE THIRTY (30) DAY PERIOD FOLLOWING THE DATE OF PURCHASE.

## 1. License

The software and documentation that accompanies this license (collectively the “Software”) is the property of VIPcom and is protected by copyright law. While VIPcom continues to own the Software, You will have certain rights to use the Software after Your acceptance of this license. This license governs any releases, revisions, or enhancements to the Software that VIPcom may furnish to You. Except as may be modified by a VIPcom license certificate, license coupon, or license key (each a “License Module”) that accompanies, precedes, or follows this license, Your rights and obligations with respect to the use of this Software are as follows.

You may:

1. use one copy of the Software on a single computer. If a License Module accompanies, precedes, or follows this license, You may register such a number of users as licensed to You by VIPcom as provided in Your License Module.
2. make one copy of the Software for archival purposes, or copy the Software onto the hard disk of Your computer and retain the original for archival purposes;
3. use the Software on a network, provided that You have a licensed copy of the Software for each computer that can access the Software over that network;
4. after written notice to VIPcom, transfer the Software on a permanent basis to another person or entity, provided that You retain no copies of the Software and the transferee agrees to the terms of this license; and
5. use the Software in accordance with any additional permitted uses set forth below.

You may not:

1. copy the printed documentation that accompanies the Software;
2. sublicense, rent, or lease any portion of the Software; reverse engineer, decompile, disassemble, modify, translate, make any attempt to discover the source code of the Software, or create derivative works from the Software;
3. use the Software as part of a facility management, timesharing, service provider, or service bureau arrangement;

4. use a previous version or copy of the Software after You have received and installed a disk replacement set or an upgraded version. Upon upgrading the Software, all copies of the prior version must be destroyed;
5. use a later version of the Software than is provided herewith unless You have signed upgrade contract or have otherwise separately acquired the right to use such later version;
6. use, if You received the software distributed on media containing multiple VIPcom products, any VIPcom software on the media for which You have not received a permission in a License Module.
7. use the Software in any manner not authorized by this license; nor
8. use the Software in any manner that contradicts any additional restrictions set forth below.

## **2. Product Installation and Required Activation**

There are technological measures in this Software that are designed to prevent unlicensed or illegal use of the Software. You agree that VIPcom may use these measures to protect VIPcom against software piracy. This license and the Software containing enforcement technology require activation as further set forth in the documentation. During activation and after download You will provide Your unique product key accompanying the Software and computer configuration in the form of an alphanumeric code sent to You by email to verify the authenticity of the Software. If You do not complete the activation within the finite period of time set forth in the documentation, or as prompted by the Software, the Software will cease to function until activation is complete, which will restore Software functionality. In the event that You are not able to activate the Software over the Internet, or through any other method specified during the activation process, You may contact VIPcom Customer Support using the information provided by VIPcom during activation, or as may be set forth in the documentation.

## **3. Limited Warranty**

VIPcom warrants that the media on which the Software is distributed will be free from defects for a period of thirty (30) days from the date of delivery of the Software to You. Your sole remedy in the event of a breach of this warranty will be that VIPcom will, at its option, replace any defective media returned to VIPcom within the warranty period or refund the money You paid for the Software. VIPcom does not warrant that the Software will meet Your requirements or that operation of the Software will be uninterrupted or that the Software will be error-free.

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, THE ABOVE WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, WHETHER EXPRESS OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NONINFRINGEMENT OF INTELLECTUAL PROPERTY RIGHTS. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS. YOU MAY HAVE OTHER RIGHTS, WHICH VARY FROM STATE TO STATE AND COUNTRY TO COUNTRY.

## **4. Disclaimer of Damages**

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW AND REGARDLESS OF WHETHER ANY REMEDY SET FORTH HEREIN FAILS OF ITS ESSENTIAL PURPOSE, IN NO EVENT WILL VIPCOM OR ITS LICENSORS BE LIABLE TO YOU FOR ANY SPECIAL, CONSEQUENTIAL, INDIRECT, OR SIMILAR

DAMAGES, INCLUDING ANY LOST PROFITS OR LOST DATA ARISING OUT OF THE USE OR INABILITY TO USE THE SOFTWARE EVEN IF VIPCOM HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

IN NO CASE SHALL VIPCOM OR ITS LICENSORS' LIABILITY EXCEED THE PURCHASE PRICE FOR THE SOFTWARE. The disclaimers and limitations set forth above will apply regardless of whether You accept the Software.

## **5. Termination**

This Agreement is effective until terminated. Upon any violation of any of the provisions of this Agreement, rights to use the Software shall automatically terminate and the Software must be returned to VIPcom or all copies of the Software destroyed. You may also terminate this Agreement at any time by destroying all copies of the Software in your possession or control.

## **6. General Terms and Conditions**

This Agreement will be governed by and construed in accordance with the laws of the Federal Republic of Germany, without regard to or application of its choice of law rules or principles. If for any reason a court of competent jurisdiction finds any provision of this Agreement, or portion thereof, to be unenforceable, that provision of the Agreement shall be enforced to the maximum extent permissible so as to affect the intent of the parties, and the remainder of this Agreement shall continue in full force and effect. This Agreement constitutes the entire agreement between the parties with respect to the use of the Software and supersedes all prior or contemporaneous understandings, communications or agreements, written or oral, regarding such subject matter. VIPcom may, in its sole discretion, modify portions of this Agreement at any time. VIPcom may notify you of any changes by posting notice of such modifications on VIPcom's web site(s) or sending notice via e-mail, postal mail or other means. Your continued use of the Software following notice of such modifications shall be deemed to be your acceptance of any such modifications to the Agreement. If you do not agree to any such modifications, you must immediately stop using the Software and destroy all copies of the Software in your possession or control.
